## Terms & Conditions

1. Any rented item not returned to the Zone within 10 days of the due date will be converted from a rental item to a sale item. Member will be responsible for the full retail price of the unreturned item plus all rental, extended viewing fees and other related charges arising from the rental prior to the conversion to a sale.
2. Member is responsible for items rented on their account when permitting the members authorized user to use their account.
3. Member is responsible for all rented items that are lost, stolen or damaged.
4. Extended day viewing fees are charged at a daily rate for each day they are late, no special pricing will be applied to these fees.
5. New releases are due the following day by 1800, favorites are five day rentals also due by 1800, games are three day rentals. Please ask for a receipt to have your due date available.
6. Member is responsible to return movie to night drop box during the hours the store is closed and during business hours please return your movie to our day drop box inside the store.

Applicant Acknowledges that he/she has read and understands the current Zone terms and conditions for membership listed above. Applicant agrees that MCCA may pursue all avenues of collection, including placing your name and social security on the suspended check cashing system. This will result in the suspension of check cashing and DPP privileges. Other action may include paycheckage or submission to the Treasury Offset Program. Applicant also agrees that MCCA may prepare and submit credit charge slips using the credit card recorded above or other credit that may have been provided for use to recover all charges and all other unpaid amounts due to non returned movies, games, damaged items or extended day viewing fees.
