THE 4 THINGS YOU NEED

- 1** Your military ID
- 2** RV, boat, or trailer registration with your name on it.
- 3** Credit card to put on file. Auto-Debit billing is a requirement for storage.
- 4** The RV, boat, trailer, etc. that you are storing. The equipment has to be measured to ensure it is being placed in the appropriate storage space.

THE 5 THINGS YOU NEED

- 1 Your military ID**
- 2 A Copy of your Deployment Orders**
- 3 Vehicle Registration with YOUR name on it**
Your vehicle cannot be stored with ANY other paperwork other than the document that declares "State Vehicle Registration" with your name on it and your vehicles VIN and License # on it. Storage of joint ownership property is prohibited unless all joint owners are authorized patrons.
- 4 Keys to door, ignition and any antitheft device (alarm remote, etc.).**
- 5 Credit Card Auto-Debit billing is a requirement for storage (\$20 Per Month)**
At the time of storage the patron will be charged for the current month and the Auto-Debit Billing will start on the 1st of the next calendar month.

Storage Agreement paperwork will be initiated / completed ONLY when the vehicle is stored. We generally have unlimited POV (car, truck, van or motorcycle) storage availability. Due to peak storage times allow 30 minutes to store your vehicle. Paperwork usually takes 5-10 minutes.

As a customer service, facility personnel disconnect the vehicle's battery upon storage and reconnect, jump start and air up tires as necessary upon removal.

If the vehicle is going to be covered with a car cover, **extra rope is necessary** to ensure effective protection. **Please write your name & phone number on the front of the car cover.** We will call if it's found in the lot. All car covers found in the lot will be stored for 3 months, then disposed of.

OTHER RECOMMENDATIONS

Vehicle's fuel tank should be stored FULL of stabilized fuel (**follow product directions**). Place an opened box of fabric softener sheets or moth balls in the engine compartment to deter rodent activity.

Close all interior vents and windows and with your hands make sure all doors, hatches, etc. are locked.

All vehicles are to be stored sitting on their tires - You are not allowed to put your vehicle up on blocks to be stored sitting on their tires.
